

Terms and Conditions of "e-Wallet Double Rewards" Promotion ("Promotion"):

- 1. The promotion period of this Promotion is from 6 Jan 2025 to 28 Feb 2025 (both dates inclusive) ("Promotion Period"). Transactions and related amounts are counted / calculated based on the relevant transaction dates as recorded by Dah Sing Bank, Limited ("Bank").
- 2. This Promotion only applies to the cardholders who are holding a Principal Card of a credit card (including but not limited to UnionPay Dual Currency Credit Card) or Co-brand Card ("Eligible Card") issued by the Bank ("Eligible Cardholders"). The Bank's Cash Card, Corporate Card, Purchasing Card, Business Card, Gift Card, Private Label Card, "Smart Choice" Balance Transfer Program Account and Cash Conversion Plan Account are not eligible.
- 3. <u>Unless otherwise specified, Eligible Cardholders cannot enjoy this Promotion and other spending promotions (if applicable) in conjunction.</u>
- 4. Each Eligible Cardholder is entitled to participate in this Promotion upon successful registration with his / her Eligible Principal Card via Dah Sing Mobile App or the designated webpage (dahsing.com/card/ewj/en) during the Promotion Period ("Successful Registration"). This Promotion is applicable to the first 5,000 Eligible Cardholders who have made the Successful Registration. Registration quota applies and is available on a first-come-first-served basis. The registration dates and time are based on the record of the Bank. Eligible Cardholder should mark down the "Registration Reference Number" as assigned upon his / her Successful Registration for verification purpose. Registration through the designated registration channels will be suspended once the quota is full.
- 5. If an Eligible Cardholder holds more than one Eligible Card, he / she is only required to register once with the Principal Card of any one of his / her Eligible Cards. Registration by any Supplementary Card of an Eligible Card is not acceptable for this Promotion. The Bank will not issue any notification if an Eligible Cardholder fails to register successfully due to provision of incorrect information (if applicable).
- 6. "Eligible AlipayHK Retail / Online Spending" refers to <u>local or overseas retail or online transactions</u> made by Eligible Card via AlipayHK during the Promotion Period, excluding mobile transfers, add-value transactions and the Ineligible Spending stated in Clause 10 of these Terms and Conditions.
- 7. "Eligible WeChat Pay HK Retail / Online Spending" refers to <u>local or overseas retail or online</u> <u>transactions</u> made by Eligible Card via WeChat Pay HK during the Promotion Period, excluding mobile transfers, add-value transactions and the Ineligible Spending stated in Clause 10 of these Terms and Conditions.
- 8. "Eligible PayMe Top-up Transaction" refers to <u>add-value transactions</u> made by Eligible Card (not applicable to Dah Sing UnionPay Dual Currency Credit Card) via PayMe during the Promotion Period.
- 9. <u>Eligible Transactions made by Eligible Card (both Principal Card(s) and Supplementary Card(s)) held</u> by the same Eligible Cardholder via individual "Designated e-Wallet" will be combined. Spending / <u>Transactions made using separate Designated e-Wallets cannot be combined.</u>
- 10. "Ineligible Spending" includes but is not limited to mobile transfers and add-value transactions (including but not limited to TNG and Tap & Go), online bill payment, cash advances, Autopay, recurring billing transactions (e.g. Octopus Automatic Add Value Service, Autotoll Automatic Top-up



Service, etc.), "Happy Installment" plan amount, Cash-In Plan, Branch Cash-In Plan, Stocks Investment Savings Plan, Balance Transfer Amount, "PayEasy" Service amount, tax payments amount, "JET payment" amount, monthly repayments of Interest-free Installment Plan, gift redemption fee, cheque payments, transactions at financial / non-financial institutions or security brokers / dealers (including but not limited to purchases of products or services such as foreign currency, money orders, travellers' cheques, securities, stocks, bonds, commodities or mutual fund, money deposits and money transfers), bank handling fees (including but not limited to annual fees, financial charges, late fees and cash advance handling fees), casino transactions, unposted / cancelled / refunded and any unauthorised transactions. The Bank reserves the right of final decision on the eligibility of any transaction.

- 11. Individual e-Wallet may impose handling charges for credit card transactions by the relevant service provider, and will be at the Eligible Cardholder's own cost.
- 12. The Bank will determine the eligibility of Eligible Transactions based on the merchant code or transaction category or type of currency as defined from time to time by the Bank or card associations (i.e. Visa International, MasterCard Asia / Pacific (Hong Kong) Limited, UnionPay International). Eligible Transactions shall be determined at the sole and absolute discretion of the Bank. The Bank shall not be liable to determine the eligibility of any transaction before it is made by an Eligible Cardholder.
- 13. Foreign currency transactions shall be automatically converted into Hong Kong Dollar on the date that the relevant transactions were processed at the rates determined by the relevant card associations (if applicable) for Eligible Transaction amount. For details of service charges related to foreign currency transactions, please refer to the List of Service Charges for Dah Sing Credit Card / Private Label Card issued by the Bank.
- 14. Any Eligible Transaction associated with the Bank's UnionPay Dual Currency Credit Card RMB account will be converted to Hong Kong Dollar based on the conversion rate of 1:1.2 of the relevant total Eligible Transaction amount and combined with the Hong Kong Dollar account.
- 15. The Bank will use the Bank's transaction records to determine the eligibility of Eligible Cardholders. Eligible Cardholder should hold the Principal Eligible Card, which is still binding with Designated e-Wallets, and maintained as valid and in good credit standing during the entire Promotion Period and when the cash rebate is offered under this Promotion ("Cash Rebate"). The relevant Eligible Transactions must be posted for the Eligible Cardholders to receive the relevant Cash Rebate. Otherwise, the Bank reserves the right to cancel the Cash Rebate without prior notice.
- 16. Each Eligible Cardholder is required to keep record of relevant transactions. In case of any dispute, the Bank reserves the right to require the relevant Eligible Cardholder to submit relevant Eligible Transaction record for verification purpose. Submitted records and documents (whether original or copy) will not be returned. The Bank reserves the right to determine the eligibility of relevant transaction.



- 17. In case of any fraud / abuse / reversal / cancellation of transactions in respect of which the relevant Cash Rebate under this Promotion is awarded, the Bank reserves the right to debit the equivalent value from the relevant Eligible Cardholders' credit card account without prior notice.
- 18. The Bank reserves the right to amend these Terms and Conditions or cancel, suspend or amend this Promotion at any time without prior notice. Should any dispute arise, the decision of the Bank shall be final and conclusive.
- 19. These Terms and Conditions shall form part of any applicable agreements governing the use of Eligible Cards and shall be construed accordingly. In case of any conflict between these Terms and Conditions and aforementioned agreements, these Terms and Conditions shall prevail.
- 20. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong. Any dispute arising under these Terms and Conditions shall be subject to the non-exclusive jurisdiction of the courts of Hong Kong.
- 21. A person who is not a party to these Terms and Conditions may not enforce any of their provisions by virtue of the Contracts (Rights of Third Parties) Ordinance (Cap.623 of the Laws of Hong Kong).
- 22. In the event of any discrepancy between the Chinese version and English version of these Terms and Conditions, the English version shall prevail.

Reward 1: Up to HKD60 Cash Rebate ("Welcome Reward")

- 1. Welcome Reward is only applicable to <u>Eligible Cardholders who have not make any transaction by using their Eligible Cards (both Principal Card and Supplementary Card) under their names in the "Designated e-Wallet" (i.e. AlipayHK / WeChat Pay HK / PayMe) during 1 Jul 2024 and 31 Dec 2024 (both dates inclusive) (regardless of whether their Eligible Card account has ever been added into the relevant e-Wallets) ("Eligible New e-Wallet Cardholders"). If an Eligible New e-Wallet Cardholder has made any transactions with Eligible Card in any one or two Designated e-Wallet(s) during the said period, Eligible New e-Wallet Cardholder is only eligible for the Welcome Reward by making transactions with the Eligible Card in other remaining Designated e-Wallet(s).</u>
- 2. Eligible New e-Wallet Cardholder must (i) successfully register for this Promotion and (ii) link an Eligible Card to AlipayHK / WeChat Pay HK / PayMe and fulfills below relevant eligible transaction requirements of Designated e-Wallet(s) by using the Eligible Card once during the Promotion Period, in order to be entitled to HKD20 cash rebate in respect of each relevant Designated e-Wallet. Even if Eligible New e-Wallet Cardholder has added more than one Eligible Card account into the same Designated e-Wallet, he / she is entitled to the HKD20 cash rebate once only for any one of the Designated e-Wallets. The maximum amount of the cash rebate for all Designated e-Wallets to which an Eligible New e-Wallet Cardholder can be entitled under Welcome Reward during the entire Promotion Period is HKD60. Details are as follows:

The cash rebate will be credited in the form of Dah Sing Credit Card free spending credit in or before June 2025 to the <u>Principal Eligible Card</u> account with the latest Eligible Transaction record during the Promotion Period of the <u>registered Eligible New e-Wallet Cardholder who has fulfilled the above designated transaction requirements on the Single Eligible Transaction Amount in respect of each <u>Designated e-Wallet</u>. The cash rebate can be used only for settlement of new transaction(s) and will be shown on the account statement of the following month for the relevant Eligible Card.</u>
- 4. The cash rebate cannot be exchanged for cash, bonus points, or other products, services or discounts. It is not refundable and transferable to third parties or other accounts, and cannot be exchanged for any other gifts.

Reward 2: Up to HKD120 Cash Rebate ("Transaction Reward")

1. Eligible Cardholder must (i) successfully register for this Promotion and (ii) links an Eligible Card to AlipayHK / WeChat Pay HK / PayMe and fulfills below relevant eligible transaction requirements of Designated e-Wallet(s) by using the Eligible Card during the Promotion Period, in order to be entitled to HKD40 cash rebate in respect of each relevant Designated e-Wallet. Even if Eligible Cardholder has added more than one Eligible Card account into the same Designated e-Wallet, he / she is entitled to the HKD40 cash rebate once only for any one of the Designated e-Wallets. The maximum amount of the cash rebate for all Designated e-Wallets to which an Eligible Cardholder can be entitled under Transaction Reward during the entire Promotion Period is HKD120. Details are as follows:

The cash rebate will be used for settlement of new transaction(s) and will be shown on the account statement of the following month for the relevant Eligible Card.
- 3. The cash rebate cannot be exchanged for cash, bonus points, or other products, services or discounts. It is not refundable nor transferable to third parties or other accounts, and cannot be exchanged for any other gifts.
