4. Eligible spending of the Promotion includes local or overseas retail transactions made by the Eligible Card ("**Eligible Spending**"). Eligible Spending does not include (but not limited to) Mobile Transfer and add-value Transactions (including but not limited to PayMe, TNG, Tag & Go etc.), WeChat Pay HK, AlipayHK, cash advances, Autopay, recurring billing transactions (e.g. Octopus Automatic Add Value Service, Autotoll Automatic Top-up Service, etc.), top-up amounts to mobile wallets (including but not limited to top-up amounts to Octopus) via any mobile payment and payment amounts in relation to adding a new Octopus on any mobile payment, Happy Installment, Cash-In Plan, Branch Cash-In Plan, Securities transaction, Balance Transfer Amount, Settle Bills Online via eBanking "PayEasy Service", Tax payment amount, "JET payment" amount, Monthly repayment of Interest-free Installment Plan, Gift redemption fee (if applicable), Cheque payment (if applicable), Bank handling fees and service charges (including but not limited to annual fee, financial charge, late fees and cash advance handling fee), casino transactions, unposted / cancelled / refunded / unauthorized / chargeback transactions.
